Parade Entry Line-Up Information

Parade Date & Start Time: Sunday, December 4 at 6:00 PM.

Line Up Location: N Adams Street between E Walnut Street and E Main Street

Line Up Time: 5:30 PM - Be on time!! (NO Judging at this Parade)

When your application is processed you will be contacted by the parade coordinator to review the following information:

- a) your parade indentifying number
- b) the line up information (location, time, etc.)
- c) the safety requirements

A parade official will be at the line up location by 5:30 PM the night of the parade. **Check in** when you arrive.

Your parade indentifying number must be attached to the FRONT LEFT side of your entry so the announcer will be able to locate the number and read the correct information as the entry passes. It is extremely important that you find your assigned location and line up in the correct direction.

Safety Requirements

1. **No objects including candy, fliers, or favors may be THROWN or DISTRIBUTED along the entire parade route.**
2. There will be no fueling of generators during the parade. Fuel cans are not allowed to be stored on the entry.
3. There will be no live fires on any entry, including in wood stoves.
4. Fire extinguishers must be carried and accessible on each float.
5. There are to be no vision obstructions to tow vehicles. An observer other than the driver is required with all towed entries. The observer can walk or ride with the entry.
6. Electrical problems are a concern with "lighted" parades. Use safe and appropriate equipment and lighting.
7. If using a generator, please place in a well ventilated area on your entry.
8. Any violation of the rules or safety requirements could result in the removal of the entry from the parade.
9. Our "live" Santa Claus will be on the last entry of the parade.
10. At the end of the parade route, each entry is requested to stay and remain "lighted" for pictures until 6:30 pm.
